BACKGROUND:

Hon'ble National Company Law Tribunal, Mumbai Bench ("Hon'ble NCLT"), passed Order on **21.10.2022** in Company Petition no. CP (IB) No.594/MB-IV/2021, filed by STATE BANK OF INDIA, the Financial Creditor /Petitioner, under section 7 of Insolvency & Bankruptcy Code, 2016 (I&B Code), for initiating Corporate Insolvency Resolution Process ("hereinafter referred to as **CIRP**") against the Company, Valecha Engineering Limited (Corporate Debtor) and appointed Mr. Anurag Kumar Sinha, Insolvency Professional having Registration Number [IBBI/IPA-001/IP-P00427/2017-18/10750] as Interim Resolution Professional (IRP), to carry out the functions as mentioned under Insolvency & Bankruptcy Code, 2016 ("hereinafter referred to as **I&B Code**").

The appointment of Mr. Anurag Kumar Sinha was confirmed/approved as the Resolution Professional ("hereinafter referred to as **RP**") of the Company by the Committee of Creditors w.e.f **30.11.2022**

As per Section 17 (1) (b) of the I&B Code, from the date of appointment of the IRP, the powers of the Board of Directors of the Company were suspended and were exercised by the Interim Resolution Professional/ Resolution Professional.

The Ministry of Corporate Affairs ("MCA") vide its Circular No. 14/2020 dated April 08, 2020, Circular No.17/2020 dated April 13, 2020, Circular No. 20/2020 dated May 05, 2020, Circular No. 02/2021 dated January 13, 2021, Circular No. 19/2021 dated December 08, 2021, Circular No.21/2021 dated December 14, 2021 and December 28, 2022 (collectively referred to as "MCA Circulars"), permitted convening the Annual General Meeting ("AGM" / "Meeting") through Video Conferencing ("VC") or Other Audio Visual Means ("OAVM"), without physical presence of the members at a common venue.

In accordance with the MCA Circulars and applicable provisions of the Companies Act, 2013 ("the Act") read with Rules made thereunder and the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("Listing Regulations"), the AGM of the Company is being held through VC / OAVM. Pursuant the provisions of section 108 of the Companies Act, 2013 read with Rule 20 of Companies (Management and Administration) Rules, 2015 as amended from time to time, and Regulation 44 of Securities Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, the Company is providing 'remote e-voting' facility through National Securities Depository Limited (NSDL) to all Members of the Company to enable them to cast their votes electronically, on all resolutions mentioned in the notice of the 46th Annual General Meeting ("AGM") of the Company.

GENERAL INSTRUCTIONS:
