## CM to move into official bungalow next month

(Standard Post Bureau) Mumbai, Feb 5 : Chief Minister Devendra Fadnavis said on Wednesday that he will move to the Chief Minister's official bungalow in city's Malabar Hills area next month.

Though sworn in as Chief Minister on December 5, 2024, he has not yet left his current residence, Sagar.

"My daughter is in Class 10 and board exams are in this month. She suggested that we relocate to the new house after her exams. So, we decided to

move into Varsha after her exams," Fadnavis said. "It is as simple as this. But I see wild speculations as to why I have not moved to Varsha, which is ridiculous and baseless."

Earlier, Shiv Sena (UBT) MP Sanjay Raut alleged that former chief minister Eknath Shinde, who is now a deputy chief minister, was reluctant to leave the bungalow. "For the first time, our CM is not occupying Varsha. He is afraid to step in," Raut said, adding, "Varsha will be demolished, and a new building will come up."

## About 300 villagers take ill after consuming 'gram' deity's 'prasad' in Kolhapur

Kolhapur, Feb 5 (UNI) : At least 100 villagers have been hospitalised after 300 of them took ill after partaking 'prasad' in annual fair of local deity Goddess Kalyantai Mata at Shrivakwad hamlet in Shirol village of the district. The 'prasad', comprising 'kheer' (a sweet preparation made from milk), was served by organisers to the villagers on Tuesday night.

However, from early Wednesday morning, some of the villagers started complaining of diarrhoea, nausea and fever due to suspected food poisoning.

About 100 persons were rushed to Indira Gandhi Memorial hospital in nearby Ichalkaraji town, where they are undergoing medical treatment. Medical superintendent Dr Bhagyarekha Patil said that considering inflow of affected patients, they have opened a special ward of 100 beds in the hospital for medical treatment and sent food samples from the fair to forensic laboratory to ascertain whether it was a case of food poisoning, she added.

## Volkswagen-Skoda urges HC to hear them on Rs 11,000 crore tax notice

Mumbai, Feb 5 (UNI) : Škoda Auto Volkswagen India Private Limited, the wholly-owned Indian subsidiary of German automotive manufacturing company, on Wednesday urged the Bombay High Court to urgently hear their plea over a Rs 11,000 crore show-cause notice from tax authorities for alleged Customs duty fraud.

The case involves the import of cars as completely knocked down units.

Advocate Naresh Thacker, along with Adv Gopal Mundhra, mentioned the petition before the bench of Justices B P Coliwalla and Firdosh Pooliwalla while stating that the plea is challenging a show-cause notice issued in September 2024 under the Customs Act.

They urged the court to urgently hear them, upon which the court agreed and adjourned the hearing and listed the matter for hearing on February 17.

The Volkswagen Group, currently led in the country by Skoda Auto Volkswagen India, has been accused of deliberately misleading Customs authorities through its mode of import of parts as individual units rather than as a component of a "completely knocked down" (CKD) unit, which attracts higher import duty.

It is understood that the alleged Customs duty fraud is applicable only to cars, which are brought under the CKD route.

The VW Group, through its various brands including Audi, VW and Skoda, sold a variety of models, which have been imported as CKD units and assembled in India. Some of the models include Octavia, Superb, Kodiaq, Passat, Jetta and Tiguan.

## Bombay HC dismisses election petition against Mumbai Cong chief

Mumbai, Feb 5 (UNI) The Bombay High Court on Wednesday dismissed an election petition challenging the victory of Mumbai Congress president and Member of Parliament (MP) Varsha Gaikwad from the Mumbai North-Central constituency in the Lok Sabha elections.

The petition was filed by a candidate Asif Siddiqui, who had challenged Gaikwad's victory alleging electoral malpractices and procedural violations in the Congress leader's poll campaign.

Siddiqui who had contested from the same constituency had alleged that Gaikwad's campaign handbills did not comply with mandatory printing norms. He further alleged that money was distributed to voters in exchange for votes.

Opposing the plea Gaikwad's advocate, Tejas Deshmukh, stated that the same was not supported by material evidence and it did not elaborate on the nature of alleged false promises made in her campaign.

Moreover, Deshmukh submitted that Siddiqui had failed to submit any videos to support his claim of bribery.

Justice Sharmila Deshmukh dismissed the election petition however detailed order is awaited.

## HC asks CBI director to set up SIT to conduct alleged fraudulent activities of Jai Corp Ltd

Mumbai, Feb 5 (UNI) : The Bombay High Court asked the zonal director of CBI to form a Special Investigation Team (SIT) to conduct a thorough probe into complaints of alleged fraudulent activities to the tune of Rs 3000 crore by Anand Jaikumar Jain, the director and promoter of Jai Corporation Ltd (Jai Corp Ltd) a company listed on the Bombay Stock Exchange and National Stock Exchange, having the main business of plastic processing, was incorporated in 1985, a lawyer said here on Wednesday. The division

bench of Justices Revati Mohite-Dere and Prithviraj K Chavan gave direction during the hearing of a plea moved by 61-year-old businessman Shoab Richie Sequeira, who in December 2021 and April, 2023 complained about Jain to the Economic Offences Wing (EOW) of the Mumbai Police. Seeking preliminary probe, Sequeira's complaints alleged fraud by Jain through various means, including misappropriation of public monies for personal enrichment, defrauding of investors, round tripping of funds through shell

companies based in tax havens, making unsecured advances to subsidiaries to launder public money and creation of dubious and fictitious invoices among others. Petitioner argued before the court that in 2021 he learnt that the Securities and Exchange Board of India (SEBI) had imposed Rs. 20 crore and 10 crore fines on two companies—Mumbai SEZ Ltd and Navi Mumbai SEZ Pvt Ltd, in which Jain was the chairman—for fraudulent futures trading in stocks of Reliance Petrochemicals Ltd (RPL). After conducting in-depth analysis, he filed

complaints before EOW, which were instead forwarded to the SEBI. Aggrieved by the same, the petitioner approached the high court.

After hearing at length, the court observed "national and international ramifications in the case" and noted that "the crimes affecting entire society cannot be ignored"; therefore, the constitution of SIT was required to "strengthen faith and strengthen confidence" of the people in the law enforcement agency and justice system, or else the same "would be shaken."

## Tripura distributes job offer to over 2700 youths

Agartala, Feb 5 (UNI) : Tripura Chief Minister Dr Manik Saha on Wednesday reiterated the transparency of his government in recruitment and governance while distributing job offer to over 2700 candidates. He said employment was provided purely on merit basis, irrespective of political affiliations, which is the unique proposition of BJP led government. Besides, entire cabinet of Dr. Saha, Union Home Minister Amit Shah joined the event virtually and underscored the commitment of Prime Minister to a transparent hiring process and applauded Tripura government. Nine candidates received their appointment letters on stage during the event. A total of 2,437 Group D positions, along with 369 posts for Pharmacists and Lab Technicians, have been filled. "Unlike in the past, when job seekers had to approach the courts for justice, we are ensuring an unbiased and systematic selection

process based on competence alone." CM said. Dr Saha also noted that in 2023, approximately 1,980 individuals secured jobs through JRBT in Group C, Agriculture Assistant, and other positions.

Between 2018 and 2024, a total of 16,411 individuals have been recruited in various government departments, with an additional 5,771 appointed on a contractual or outsourcing basis, he pointed out. Chief Minister highlighted the establishment of three Model Career Centers in Agartala, Dharmanagar, and Kailashahar, as many as 96 job fairs were hosted, facilitating employment for over 2,135 youth in private sector roles.

## Task force presents plan to make Gadchiroli Dist malaria free

Mumbai, Feb 5 (UNI) : Considering that Gadchiroli is one of the six districts in the country most affected by malaria, an important step has been taken towards making this district malaria free. For this, implementation of the district malaria eradication plan will start from April one. The plan was presented by the task force, headed by Dr Abhay Bang, Maharashtra Chief Minister Devendra Fadnavis informed on Wednesday that instructions have been given to make available Rs 25 crore through the Tribal Development Department.

As the Indian Council of Medical Research has also noted the development of insecticide resistance in mosquitoes, controlling malaria in Gadchiroli is a very important priority, he said. Accordingly, the task force has formulated a master plan for malaria eradication in Gadchiroli district incorporating recommendations from national and global experts.

## Law Says Everyone Innocent Until Proven Guilty: CM Omar Abdullah After LG Sacks Employees For Terror Links

Jammu : Jammu and Kashmir Chief Minister Omar Abdullah on Saturday questioned arbitrary dismissal of government employees for their alleged terror links by the Lt Governor saying that the law says that "every accused person is innocent until proven guilty" in the court. Lt Governor Manoj Sinha invoked Article 311 (2) (c) of the Constitution to terminate the services of the three employees on Saturday after investigation by law enforcement and intelligence agencies accused them of terror

links. So far, over 70 government employees have been dismissed on the charges of terror links over the past few years. "If there is a proof against them (dismissed employees) and they have been given an opportunity to clear the allegations but failed... if such steps are taken without hearing them, the law says that every person accused of any crime is considered innocent until proven guilty," Abdullah told reporters on the sidelines of a function here.

- Pursuant to The Taxation Laws (Amendment) Ordinance 2019, promulgated on September 20, 2019, the Company has exercised the option u/s 115 BAA of the Income Tax Act, 1961 to compute income tax at the rate (i.e. @ 25.17% inclusive of surcharge & cess). The Company has incurred losses during the quarter ended 31.12.2024 due to stock written off amounting to Rs. 300 Lakhs during the said quarter.
- The undisputed tax liability relation to TDS on Purchase, not paid by company for the FY 2022-23 amounting Rs. 1.32 Lakhs.
- Undisputed tax liability of Income tax for FY 17-18 is outstanding as at 31st December 2024 Rs. 2.91 Lakhs
- The undisputed tax liability relation to Profession Tax not paid by company for the FY 2018-19 and 2019-20 and 2022-23 amounting Rs. 2.78 Lakhs.

Employees State Insurance Corporation filed the case alleging that the stay orders are obtained by suppressing or misrepresenting the material facts to obtain orders and hence to award punishment in accordance with law. Application is rejected and proceedings are closed.
  - Case No. ESI No. 23 of 2012 filed in the Hon'ble Employees Insurance Court, Mumbai by ESIC for contempt case against the company and Director Riyaz Ganji. Order against the case is partly allowed. The dispute is remanded back to decide afresh liability of contributions on Libas' Fashionians and its proprietor.
  - ESI Cases filed against Company.
  - Case No. 267/SW/2012 filed for non-payment of contribution for the period February 2007 to December 2011 of Rs. 11,59,373/- .
  - Case No. 2512447/2012 filed for non-submission of Return of contribution from April 2006 to September 2011 in due dates i.e. within 42 days from the expiry of contribution period. Both the cases were filed on October 10, 2012 in Sewree Court, Company has attending the case. The said cases are also pending in E.I. Court/Bandra, Mumbai at final stage.
  - The Company has filed Revision Appeal U/s 34 before Bombay Highcourt against the Arbitration order. The arbitration order dated 09/08/2021 received by the Company. The arbitrator has given order to pay INR 1,48,48,593/- to respondent. The company has not recorded the said liability in the books of account. Petition against the order is filed at Bombay High Court.
  - Managing Director Mrs. Reshma Ganji has filed case in NCLT against the company. Company has filed petition in June 2023 in NCLT. Case is not admitted in NCLT.
- Management has written off obsolete stock amounting to Rs. 300 Lakhs during the quarter ended 31.12.2024.
